



# St Peter's Preschool

## Schedule of Fees 2025/26

### 1. St Peter's Preschool Fees

Full time <3 (8.30am - 3.30pm) including lunch (discounted by £7 for booking a full day)	<b>£67.90</b>
Part day (8.30am - 11.30am or 12.30pm - 3.30pm) without lunch	<b>£28.99</b>
Part day (8.30am - 12.30pm or 11.30am - 3.30pm) with lunch	<b>£43.41</b>
Extra hour (8.30am - 9.30am)	<b>£8.91</b>
Consumables (voluntary)	<b>£2.25</b>
Lunch & snacks	<b>£5.51</b>

Additional wrap-around care is available from 8am until 5.30pm at a cost of £8 per hour, charged by the half hour or part thereof.

### 2. Government Funded Sessions

Parent/Carer eligibility is to be confirmed before funding is applied to termly invoices.

Funded places are subject to availability and the rules in place set by North Northants Council as the funding authority. Consumables are optional.

Universal (15 hours funded place) - PMs only ( 11.30am - 3.30pm) - inclusive of optional additional care with lunch (11.30am - 12.30pm)	<b>£16.68</b>
30 hour funded place (8.30am - 3.30pm = 6 hours per day funded inclusive of optional additional care and lunch (8.30am - 9.30am)	<b>£16.68</b>
Lunch & snacks	<b>£5.51</b>

All fees are payable termly in advance, unless a monthly direct debit payment scheme has been agreed with the Bursar. Childcare Vouchers and the Tax Free Childcare Scheme are accepted for preschool fees.

### 3. Sibling Discounts

For existing St Peter's families with a child on roll as at 31/08/25 - there will be a 10% reduction in net fees above (excludes Government funded sessions) for the first sibling attending preschool.

For new St Peter's families from 01/09/25 - There will be a 2.5% reduction in net fees above (excludes Government funded sessions) where two or more siblings are on roll at St Peter's at the same time.

### 4. Deposits, Registration Fees & Notice Period

A non-refundable registration fee of £90 (£75 + VAT) is payable on registration with the Preschool.

To secure a place a deposit of £750 is payable which will be refunded against the final Year 6 terms fees. Should the deposit not be refunded then VAT will be payable at the applicable rate.

**A full term's notice to leave is required** and full fees are payable during this period, or payable in lieu of notice if the child is removed from preschool early.
